CONDITIONS OF CONTRACT BETWEEN THE JCC AND ARTIST:

Mission of the JCC Gallery: At the heart of the JCC of Indianapolis' mission statement is the notion, "The Center shall enrich the life of the Jewish and general communities by developing and implementing programs for their recreational, educational, cultural, physical, and social needs." One vital element of that mission concerns the role the Indianapolis JCC plays in the cultural life of the Jewish and general communities. The mission statement of the Cultural Arts Department lists the objectives to be, "To provide the community with a comprehensive arts and education program encompassing the areas of music, theater, dance, visual arts, classes, workshops, and special events that will bring to the community the richness of Jewish cultural experiences..." The JCC is home to a variety of audiences – children, young adults, and seniors. **We are sensitive to these diverse audiences. As such, nudity, overt violence, and any other representation of acts of an offensive character may be excluded from the exhibit at the discretion of the Cultural Arts Committee or Board of Directors. All such actions taken by the Cultural Arts Committee or Board of Directors will be consistent with both the mission statement of the agency and the mission statement of the Cultural Arts Department.**

Transportation: The Artist is responsible for **all** roundtrip shipping/insurance charges, unless subsequently notified in writing by the JCC.

Insurance: The Artist is responsible for insurance coverage of the work.

Sale of Work: The JCC will make available a price list to visitors. The Artist and the JCC will establish the sales price. All sales carry a 30% sales commission to the JCC. Sales will be made payable to the JCC, who will forward the sales price, less 30% sales commission, to the Artist within six (6) weeks after the close of the exhibit. The Artist agrees that he/she has not engaged any other person for a commission, finder's fee, or similar obligation in connection with the works contained in the exhibition. Additionally, any work from the exhibition sold during the three (3) months following the close of the exhibition to a buyer who indicated that the work was originally seen at the JCC is subject to the same 30% sales commission, which must be forwarded by the Artist.

2-D Art: The Artist is responsible for delivering all works framed, wired and ready to hang using the JCC hanging apparatus, and/or easels. If any framing or alteration must be done to install the works, the JCC will bill the Artist for such alterations. Art works damaged by faulty framing or wiring will be the sole responsibility of the Artist, and the JCC may not be held liable for damage resulting from such circumstances. It is at the discretion of the JCC where to exhibit art within the building.

3-D Art: If a pedestal is necessary to display the exhibit piece(s), it is the responsibility of the Artist to provide it. It is at the discretion of the JCC where to exhibit art within the building.
